As required by the Cybersecurity Information Sharing Act of 2015 (CISA), we are initiating an evaluation of the sharing capabilities used by the U.S. Department of Commerce. Pursuant to the requirements in CISA, we will assist in creating an interagency report on the actions taken by the executive branch of the federal government to carry out this title during calendar years 2021–2022.

The joint report will be issued through a committee led by the Office of the Inspector General of the Intelligence Community. Attached is the committee's announcement memorandum, which includes its objective.

- (U) In December 2015, Congress passed the Consolidated Appropriations Act of 2016 (Public Law 114-113), including Division N the Cybersecurity Act of 2015. Within the Cybersecurity Act, Title I the Cybersecurity Information Sharing Act of 2015 (CISA), Section 107, *Oversight of Government Activities*, requires the Inspectors General of the "appropriate Federal entities¹, in consultation with the Inspector General of the Intelligence Community and the Council of Inspectors General on Financial Oversight" to jointly report to Congress on actions taken over the most recent two-year period to carry out CISA requirements.
- (U) The objective of this project is to provide a joint report on actions taken during calendar years 2021 and 2022 to carry out CISA requirements. Specifically, we will report on:
 - (U) The sufficiency of policies and procedures related to sharing cyber threat indicators within the Federal Government.
 - (U) Whether cyber threat indicators and defensive measures have been properly
 classified, as well as an accounting of the security clearances authorized for the purpose
 of sharing cyber threat indicators or defensive measures with the private sector.
 - (U) Actions taken to use and disseminate cyber threat indicators and defensive measures shared with the Federal Government.

¹ (U) CISA designates the Office of the Director of National Intelligence and the Departments of Commerce, Defense, Energy, Homeland Security, Justice, and Treasury as the appropriate Federal entities.

- SUBJECT: (U) Assessment of and Joint Report on the Implementation of the Cybersecurity Information Sharing Act of 2015, (AUD-2023-002)
 - (U) Specific aspects of cyber threat indicators or defensive measures that have been shared with the Federal Government, including:
 - (U) The number of cyber security threat indicators or defensive measures shared using the capability [Automated Indicator Sharing] implemented by the Department of Homeland Security
 - (U) Instances in which any federal or non-federal entity shared information that was not directly related to a cybersecurity threat and contained personally identifiable information (PII)
 - o (U) The number of times, according to the Attorney General, that information shared under this title was used by a federal entity to prosecute an offense listed in CISA Section 105(d)(5)(A)
 - O (U) The effect of sharing cyber threat indicators or defensive measures with the Federal Government on privacy and civil liberties of specific persons, including the number of notices that were issued with respect to a failure to remove information not directly related to a cybersecurity threat that contained PII
 - (U) The adequacy of steps taken by the Federal Government to reduce any adverse effect from activities carried out under this title on privacy and civil liberties of specific persons.
 - (U) Barriers affecting the sharing of cyber threat indicators or defensive measures.
- (U) The inspectors general for the Departments of Commerce, Defense, Energy, Homeland Security, Justice, and Treasury, and the Office of the Director of National Intelligence will prepare the report of compliance with Section 107 by December 2023.
