SUBJECT: Audit of Commerce's Cloud-computing Environments

We plan to conduct an audit of the Department's cloud-computing efforts. This work is part of a federal government-wide audit sponsored by the Council of Inspectors General on Integrity and Efficiency (CIGIE). The objectives will be to (1) evaluate the Department's efforts to adopt cloud-computing technologies and (2) review executed contracts between the Department's bureaus and cloud service providers for compliance with applicable standards. The results of our work will also be included in a consolidated CIGIE report.

We will contact your audit liaison to schedule an entrance conference. Our fieldwork will begin Commerce-wide. Based on the results of a cloud computing survey, we will make selections from bureaus as to which systems we will include in our detailed audit testing. We plan to interview program officials and review pertinent records related to Commerce cloud systems.

To begin our review, we are requesting some initial documentation that we will need for the audit. Please provide us by January 30, 2014, with a completed cloud computing survey (see attachment), in electronic format if possible.
